3. Method of Entry

Earn Entry Period: Starting at 9:00am through 9:00pm September 4, 11, 18, and 25, 2025 (Promotional Period”).

For 100 base points earned, Lucky North Rewards members will be eligible to print a voucher to redeem for a gift.

Vouchers must be printed out at a promotional kiosk starting at 2:00pm.

4. Prizes

Promotional gift chosen for week.

If gifts run out before 9pm, \$15 in Free Play will be given until the end of the promotion.

5. Event Date/Time

6. Entry Activation

Members must present their Lucky North Rewards card, valid photo ID, and printed voucher at the promotional stage.

Manual printed vouchers from kiosk when eligible.

8. Restrictions

Entries that were printed for the specific Thursday date can only be used on specified date.

No duplicates, reproductions or facsimiles will be accepted.
