##### 3. Method of Entry

Participants can print one entry from the kiosk each day and deposit it into the drawing barrel on the first three Sundays in December.

##### 4. Prizes

#### 5. Drawing Date/Time

#### 6. Entry Activation

- Guests may put their entries into the drum by the stage starting at 12:00pm, one (1) hour before the drawings start.

#### 7. Drawing Method
