



Official Rules

Promotion Title: Manic Monday Multiplier

Participation Criteria:

- A Member of Lucky North Rewards at Mardi Gras Casino & Resort
 - Must be 21 years of age or older.
 - Any participant visiting Mardi Gras Casino & Resort will be eligible to receive a Lucky North Rewards Membership.
 - Participants must provide a valid photo ID to become a Lucky North Rewards Member.
 - Membership is provided free of charge.
- It is the cardholder's responsibility to ensure that their card is properly inserted into the card reader on the slot machines before playing begins. Improper insertion may result in the loss of points or eligibility which otherwise would be earned.
