



## Official Rules – Table Games Multiplier Promotion

Promotion Title: Table Games Multiplier

Promotion Dates: Mondays & Tuesdays – April 2026

Event Time: 9:00 AM – 11:59 PM

### 1. Eligibility

- Must be 21 years of age or older.
- Must be an active Lucky North® Rewards Member. Membership is free.
- Must present valid, government-issued photo ID to verify eligibility.
- Employees of Delaware North, Mardi Gras Casino & Resort, subsidiaries, affiliates, and immediate family are not eligible.
- Immediate family includes spouses, parents/step-parents, children/step-children, siblings/step-siblings, and individuals living in the same household 3+ months per year.
- Guests must ensure their Lucky North card is inserted correctly into the machine to accrue play ratings for multiplier eligibility.

### 2. Event Schedule

- Promotion operates every Monday and Tuesday in April from 9:00 AM – 11:59 PM.
- Multipliers earned on Monday apply to Tuesday's play; multipliers earned on Tuesday apply to the following Monday.
- Visits must be consecutive to maintain escalating multiplier benefits.

### 3. How to Earn Multiplier

- Guests earn a 2× table games multiplier by participating in eligible table games during promotional hours.
- Eligible games include blackjack, craps, roulette, and proprietary carnival games.
- Play is tracked electronically; guests must remain rated for the entire session to qualify.
- To activate the multiplier, guests must swipe at a promotional kiosk each promotional day.
- Failure to activate at the kiosk voids eligibility even if table play occurred.

### 4. Prize Details

- Qualified guests receive a 2× multiplier applied to the following promotional period's table game play.
- Multiplier applies to base table ratings only; bonus rewards are excluded.
- Multiplier impacts comp earnings, promotional points, and select reward calculations depending on game type.
- Guests who maintain attendance for multiple consecutive periods may stack eligibility but will never exceed a 2× multiplier.

## 5. Redemption Details

- Multiplier must be redeemed at a promotional kiosk each Monday and Tuesday from 9:00 AM – 11:59 PM.
- Guests must complete kiosk activation before any rated table game session to ensure proper application.
- If a kiosk is out of service, guests must notify Rewards Staff for manual verification.

## 6. Entry Activation

- Guests must activate the multiplier in person at the promotional kiosk.
- Activation generates a timestamp that links the multiplier to the guest's account.
- Failure to activate results in forfeiture of earned multiplier for the day.

## 7. Multiplier Method

- Multiplier is calculated automatically by the rating system during the following promotional period.
- Only table game activity tracked with the player card inserted is eligible.
- Multiplier cannot be applied retroactively and cannot be combined with other multipliers.

## 8. Restrictions

- Multipliers are non-transferable and hold no cash value.
- Photocopies, screenshots, or altered vouchers are not accepted.
- Multiplier not awarded during a guest's first visit in a consecutive cycle.
- Only eligible table games qualify for multiplier application.

## 9. Acceptance

- Valid identification must be presented before any reward is applied.
- Guests may be required to sign promotional documentation, including IRS forms when applicable.
- Management reserves the right to verify compliance prior to issuing promotional benefits.
