



Official Rules – Sit & Go Tax Day Drawing Promotion

Promotion Title: Sit & Go Tax Day Drawing

Promotion Date: Wednesday – April 15, 2026

Event Time: 4:00 PM – 8:00 PM

Entry Drop Period: 2:00 PM – 7:55 PM

1. Eligibility

- Must be 21 years of age or older.
- Must be an active Lucky North® Rewards Member. Membership is free.
- Must present valid, government-issued ID.
- Employees of Delaware North Companies, Mardi Gras Casino & Resort, subsidiaries, affiliates, and immediate families are not eligible.
- Anyone on the casino's self-exclusion, banned, or trespass list is not eligible.
- Guests must ensure their Lucky North card is properly inserted when printing entries.

2. Event Schedule

- Entry ticket printing begins at 2:00 PM.
- Drawing times occur at 4:00 PM, 6:00 PM, and 8:00 PM.
- Three winners will be selected for each drawing.
- Guests must drop printed entries into the drawing barrel before 7:55 PM.

3. Method of Entry

- Guests must print their Sit & Go Tax Day Drawing ticket at any promotional kiosk.
- Each guest receives one (1) entry ticket
- Entries must be placed in the designated drawing barrel to be eligible.
- Illegible, altered, or damaged tickets may be disqualified.

4. Drawing Details

- Three (3) names will be drawn at each scheduled drawing time.
- Guests have three (3) minutes to report to the stage once their name is announced.
- If a guest does not appear on time, an alternate will be selected.

5. Prize Details

- Selected guests will enter the Money Machine for a 30-second session for a chance to win up to \$2,500 cash
- Guests must follow all instructions and cannot touch machine walls or scoop bills
- Collected promotional bills convert to cash

6. Claiming Prizes

- Winners must present valid ID and their Lucky North Rewards card.
- IRS W-9/1099 forms may be required depending on the award value.
