



## **Mardi Gras Casino and Resort Truck Bucks Use Policy**

1. Truck bucks were designed to offer guests the ability to purchase food from various food trucks during events where food is offered from an external vendor.
2. Trucks bucks have NO monetary value and may not be exchanged for cash.
3. Truck bucks have NO breakage, so redemption is all in. If a guest presents a Truck Buck and the value is greater than the purchase amount, no change will be given.
4. A receipt indicating the amount redeemed shall accompany all Truck Bucks. If a receipt is not attached to the Truck Buck, it may not be valid and may not be reimbursed.
5. A representative from Mardi Gras will collect the redeemed Truck Bucks at the conclusion of the event.
6. Truck bucks will be tallied and the amount written on the bag or envelope. The total should be verified by both parties (vendor and casino representative).
7. A verification will be required to ensure that the value of the Truck Bucks is mutually agreed upon and the bag or envelope will be signed and dated by both parties.
8. If all required vendor paperwork has been submitted by the Food Truck, payment will be made as soon as the process for approval has been completed to the method of payment indicated.
9. If all required vendor paperwork has not been submitted by the Food Truck, payment will be made once this process has been completed and will be paid to the method of payment indicated.
10. Incorrect or invalid Truck Bucks Coupons or Vouchers will not be counted towards payment owed. Only Mardi Gras kiosk vouchers or Truck Bucks coupons showing the proper event date will be counted.
11. Management reserves the right to cancel or modify these terms at any time.

## **Mardi Gras Casino and Resort Vendor Policy**

1. Mardi Gras is not responsible for unattended tables, lost, stolen or forgotten items. If anything remains on our property overnight, it will be at the vendor's own risk.
2. In the event you are forced to close by any government agency for failure to obtain your necessary permits and/or licenses, Mardi Gras is not liable and will not refund fees. No exceptions will be made to this because of failure to abide by local or state regulations.
3. Vendors must provide their own tents, tables, chairs, shade cover/tent, lights, etc.
4. Location of booth will be assigned by event coordinator.
5. No exclusives will be granted regarding booth location, space is limited and subject to approval.
6. Vendor is required to be open to the general public for the duration of the entire event. Closing to the public before the end of the event or staying open to the general public after the end of the event is grounds for exclusion from participating in future events.
7. Mardi Gras will not allow the sale of merchandise at the event that offends community standards or depicts drug use, weapons, political items, or related paraphernalia.
8. PHOTO RELEASE: The participants hereby give permission to Mardi Gras and its assignees to take photographs, make audio recordings and /or videos of the participants and their representatives or employees at the event and to use such photographs, audio recordings, and/or videos for such promotion or other lawful purpose as deemed appropriate.

All vendors must agree to the rules and requirements.
