



Official Rules – 50+ Lucky Legends Promotion

Promotion Title: 50+ Lucky Legends Kiosk Game

Promotion Dates: September 1, 8, 15, 22, 29

Event Time: 9:00 AM – 11:59 PM

1. Eligibility

- Must be 50 years of age or older to participate.
- Must be an active Ember® Rewards Member. Membership is free.
- Must present a valid, government-issued photo ID to verify age and membership.
- Employees of Delaware North Companies, Mardi Gras Casino & Resort, subsidiaries, affiliates, and immediate family members are not eligible.
- Immediate family includes spouses, parents/step-parents, children/step-children, siblings/step-siblings, and anyone living in the same household at least 3 months per year.
- Guests must ensure their Lucky North card is properly inserted to accrue base points during rated play.
- A designated substitute or proxy may be used if a claimed winner is unable to participate.
