



Official Rules – Climb the Ladder Kiosk Game Promotion

Promotion Title: Climb the Ladder Kiosk Game

Promotion Dates: October 5th, 12th, 19th, 26th

Event Time: 9:00 AM – 11:59 PM

1. Eligibility

- Must be an active Ember® Rewards Member. Membership is free.
- Must present valid, government issued photo ID to join the Ember Rewards.
- Employees of Delaware North Companies, Mardi Gras Casino & Resort, subsidiaries, affiliates, and immediate family members are not eligible.
- Immediate family includes spouses, parents/step-parents, children/step-children, siblings/step-siblings, and anyone living in the same household at least 3 months per year.
- Guests must ensure their card is properly inserted into the reader to accrue base points correctly.

2. Event Schedule

Guests may participate on the promotional dates in October from 9:00 AM to 11:59 PM. The kiosk game resets weekly.

3. Method of Entry

- Guests earn access to the kiosk game by accumulating base points during promotional hours.
- Every time a player reaches the next qualifying point threshold, they gain an additional play.
- Base points must be earned through rated slot or table play while using the Ember Rewards.
- Points earned prior to the promotional period do not count toward kiosk eligibility.

4. Prize Details

- 100–199 points – up to \$50 Free Play
- 200–299 points – up to \$250 Free Play
- 300–399 points – up to \$500 Free Play
- 400–499 points – up to \$750 Free Play
- 500–749 points – up to \$1,000 Free Play
- 750–999 points – up to \$2,500 Free Play
- 1,000+ points – up to \$5,000 Free Play
- Prize outcomes vary depending on the result of the kiosk game animation and random award structure.
- Free Play awarded from the kiosk will load automatically onto the guest account

5. Entry Activation

- Guests must visit any promotional kiosk to activate and redeem their earned plays.
- Kiosk instructions appear on-screen and must be followed for successful prize redemption.
- If a kiosk is malfunctioning, guests should immediately notify Rewards Staff for assistance.

6. Kiosk Game Method

The kiosk game awards prizes based on random digital outcomes tied to the points earned threshold. Each qualifying play guarantees a prize within the appropriate tier. Play starts over each promotional date.

7. Restrictions

- Guests must activate the kiosk game on the promotional day points that were earned.
- Prizes are non-transferable and cannot be redeemed for cash.
- Guests may not redeem kiosk prizes on behalf of others.
- No duplicates, reproductions, or facsimiles of vouchers are accepted.

8. Acceptance

- Winners may be required to complete Eligibility, Liability, and Publicity Releases, and IRS forms if applicable.
- Failure to complete documents may result in the forfeiture of the prize.
