



Official Rules – Thursday Gift Giveaway Promotion

Promotion Title: Thursday Gift Giveaway

Promotion Dates: Thursdays – October 8th, 22nd, 29th

Event Time: 3:00 PM – 9:00 PM

1. Eligibility

- Must be 21 years of age or older.
- Must be an active Ember® Rewards member. Membership is free.
- Must present valid, government-issued photo ID to verify identity and eligibility.
- Employees of Delaware North Companies, Mardi Gras Casino & Resort, subsidiaries, affiliates, and immediate families are not eligible.
- Immediate family includes spouses, parents/step-parents, children/step-children, siblings/step-siblings, and persons living in the same household at least 3 months per year.
- Guests must ensure their Ember Rewards card is properly inserted to accrue points during rated play.
- Guests found attempting to manipulate entry earning, kiosk use, or voucher duplication will be disqualified.
- A designated substitute or proxy may be used if a claimed winner is unable to participate.

2. Promotion Schedule & Location

- Gift redemption occurs Thursday from 3:00PM-9:00PM on promotional dates.
- Redemption location: Ember Rewards Promotional Stage.
- Line management protocols may be implemented to ensure efficient flow and fairness.

3. How to Earn Entries

- Earning period: 9:00 AM – 9:00 PM each promotional Thursday.
- Ember Reward members must earn 150 base points each promotional date
- Invited Ember Rewards members may receive the gift without earning points by presenting their Ember Rewards card.
- Points cannot be shared, combined, or transferred between accounts.

4. Entry Activation

- Guests must print vouchers at a promotional kiosk to receive a gift
- If a voucher misprints, guests must notify a team member at the Ember Rewards desk immediately for verification and potential reprint.
- Guests should not leave the kiosk area until they confirm voucher readability.

6. Restrictions

- Prizes are non-transferable and cannot be redeemed for cash.
- Guests may not redeem prizes on behalf of others without manager/hosts approval
- Lost, damaged, or stolen vouchers will not be reissued unless verified by system logs.
- Vouchers may not be duplicated, copied, or altered in any form.

- IRS W-9 or 1099 documentation may be required based on gift value.
- Refusal to complete required documentation results in the forfeiture of the prize.

Should the prospective winner be unable to return to Sponsor's Venue with proper identification within 24 hours, the offer, gift, or prize, shall be forfeited, unless management approves an extension of time due to extenuating circumstances.
